The Tom Thumb Good Neighbor Program makes it easy for any church, school, or approved non-profit organization to raise funds with no selling and no up-front investment. Most of our customers use their Club Card or Phone # each time they shop because of the benefits the program offers. Customers save money, earn gas and grocery rewards while supporting their favorite organization/s. Your Good Neighbor Program account number can be linked to a customer's individual Loyalty account so your organization can accumulate funds quicker and easier.

It's fast.

Once your organization has been approved, it will be assigned an exclusive account number. That number must be communicated by your organization to members and supporters of your group. Your members can then link your organization's Good Neighbor account number to their individual Loyalty account with the Customer

Add/Delete form. This form is available at:

Tom Thumb.com – click on the Community Caring link at the bottom of the homepage, then click on the Good Neighbor icon and scroll down. Please alert your members and supporters to follow the instructions on the form. Once their information is linked to your account, their purchases will be recorded automatically to your organization's Good Neighbor account. We will keep a running total, and each calendar quarter, we'll send your organization a check for one percent of the total amount.

Keep in mind that each customer can have up to three organizations liked to their Loyalty account. The amount directed to your organization is based on the total number of organizations linked to each Loyalty account in a household.

It's Rewarding.

The Tom Thumb Good Neighbor Program allows us to support thousands of community endeavors. We make most of our contributions through this program. Tom Thumb will pay one percent of the total grocery purchases in your account to your fund-raising organization. The amount of your payment depends upon the amount of your group's accumulated total, so be sure to publicize your Good Neighbor Program account number!

Payment Schedule:

Tom Thumb pays your organization one percent cash per calendar quarter on total purchases.

If purchases total less than \$2,500, your purchases will automatically roll over to the next quarter, until the end of the fourth quarter when all accounts will be paid out and reset to \$0.

Once the quarterly payment has been made to your organization, your account will revert to \$0 and accumulate again for the next quarter.
